V. EDUCATIONAL SERVICES

5.1 Student Body Reports – Natalie Hewey, Monticello President presented – On April 2nd the Monticello Science Olympiad team placed 17th overall out of 54 teams. Natalie gave special thanks to all participants and to Mrs. Henley, Mrs. Hillstead & Mrs. Hopson, the Science Olympiad coaches. The character pillar for this month is Citizenship. The 3rd & 4th grade students began CAASP testing. Progress reports will be going home this week. On April 21st, Monticello will host Family Science Night with an “X Marks the Spot” theme. Spirit Day this month is Pajama Day and it will be held on April 29th.

Alexandra Manzo, President for Hawkins presented – Hawkins Jump Rope for Heart was a success and students wore extreme blue for this event. The Memuro students from Japan enjoyed the school dance. Hawkins will be hosting their Annual Spaghetti Dinner & Dance Auction coming soon. Girl's 7th and 8th grade basketball teams played against each other in the championship tournament. CAASP testing is up and running for 4, 7 & 8 grade. DARE graduation for 5th grade is coming up as well.

Ashleigh Hewey, an ASB representative, spoke for Jefferson School – On March 16th, Spring Performances occurred at Jefferson School. The students enjoyed participating and making their performances on their own. The basketball season has come to a close. Jefferson School had a staff vs. 8th grade basketball game which the staff won because there was no instant replay. The Wildcat Rally went well and was emceed by Ms. Wooten. Students had to meet certain standards in order to participate in the rally. Physical Fitness and CAASP testing are taking place this week. Coming up, Jefferson School will have a Hawaiian Dance, as well as a GATE field trip.

Reyva Dhillon, Traina President presented – Anthony Traina School has had an eventful couple of weeks. The upcoming Traina Spirit Day will occur on April 22nd with an Earth Day theme. College Week was last week with unique spirit days that occurred throughout the entire week. The College Week Rally was a blast with Traina's 6th grade winning the rally. 8th graders are studying for exit interviews which occur mid-May. Next week the ASB is hoping to have a Root Beer Float fundraiser.

5.3 English Learner Report Plan Update – Sarah Steen presented data on the District English learner population including percentages of English learner populations per site, district totals by CELDT levels, and what languages are spoken at home for our English learner populations. The numbers of English learners by site are similar to what we had last year in our district. The number of students who were reclassified in 2015-2016 was presented. Ms. Steen noted that reclassified students no longer take the CELDT test but are still monitored. Professional development that occurred this year such as GLAD training; Paras and Instructional Aides attended the Paraprofessional Institute and Ellevation system training was shared. The English Learner Report Plan was noted on the agenda as an action item incorrectly, it is only an informational item.

the Instructional Coach position in 2016-2017 to a District position. One additional FTE will be
shared by Monticello and Jefferson school was proposed as well. The existing 2 FTE will move
\$131,000 from site budgets to District funded positions. Ms. Maxedon noted that the District will
provide 4 hours (2 2-hour positions at Monticello, Hawkins and Traina) for all day Kindergarten
support for the first year only. New positions will be created if this is approved by the Board tonight.
Mandated Costs budgeting were reconfirmed as well. Additional assumptions will be presented later.
