V. EDUCATIONAL SERVICES

5.1 Student Body Reports – Natalie Hewey, Monticello student council president, provided her school's report. The current character pillar is respect and October is bully prevention month. There will be a school-wide poster contest and other activities. She passed out ribbons, which students also received, as a reminder to always treat others that way you want to be treated. Last Friday evening, students and families got together and watched Monsters University on the Monticello lawn. The annual Fun'd Run is this Friday. From October 26th to 30th, student will participate in red-ribbon week activities. The recycling program is back and serves as an example of how students give back to the community.

Alexandra Manzo, ASB president, gave the Hawkins School report. Hawkins had a flash donation for people affected by the Butte fire. There was such great participation that a second donation event was scheduled – a Halloween costume donation event. Student council planned and carried out the recent Fun Friday, for Kindergarten through fifth grade students, and the theme was carnival. Pajama jam is the next dance planned for November 6. Student council is also working with staff to help the school run more smoothly through programs like student council/staff traffic lines and recycling. Police officers and school officials greeted students and parents during the annual Walk to School day recently. She looks forward to 2015-16 being a great year.

Jefferson ASB President Cierra Spikes reported on her school's activities. Recent events include DJ music at lunch where students had a fun time singing and dancing. College week had great participation from all the grades, however eighth grade took the win in the spirit competition. She thanked Dr. Bridges for his assistance with the rally. Sixth graders returned from science camp and said it was memorable and fun. Coming up, students will participate in Red Ribbon Week activities to remind them to be drug free. The next dance is October 30 and is a Halloween theme. Students are encouraged to dress in costume.

Jabari Vaugh, Vice-president and Cassidy Hunter, secretary, from Traina ASB, gave a joint report from their site. The Kona Ice event was a big hit for students. Spirit day participation has been off the charts and each Thursday this month students wear pink in honor of breast cancer awareness. ASB will be selling Traina water bottles as a fundraiser. Auditions have concluded for the spring musical *Hairspray, Jr.* Starting afterschool clubs has been a topic of discussion so the constitution will be reviewed regarding this possibility. The annual walk-a-thon took place two weeks ago and was very successful.

5.2 Special Education Department Report – Director of Special Education Angelica Thomas introduced members of the special education department that were in attendance. Her presentation provided a reminder of what special education is and a district staffing snapshot.

She shared details of the special education focus which includes increased communication and collaboration, training of general and special education staff, and a focus on high expectations for all students. The district also partners with SJCOE, SELPA, VMRC and other contract agencies that supplement our staffing. Student data was presented by school, grade, disability categories, and placement.

Next steps and ongoing focus in special education will include communication and collaboration with staff and families, fiscally responsible program development, evaluate staffing needs, and systematic staff training and support.

5.5 Jefferson Band Disneyland Trip – Amanda Gieseke, Jefferson Band director and Shawntai Robertson, Jefferson parent were introduced by Dr. Bridges. Current Board Policy 6153 precludes overnight trips unless approved by the board.

Ms. Gieseke proposed a three day, two night trip to Disneyland in March or April for her marching band students. Details of the proposal included charter bus quotes, hotel information, GPA and other qualifiers for students. This trip is optional for students and all eligible students will be allowed to participate regardless of the family’s ability to contribute to the cost. Fundraisers will be planned. There is an application process with a response time of approximately eight weeks, but she requested board approval before she moves forward with the application.

Mrs. Robertson shared her experience as a chaperone of a Tracy High student that took the same Disneyland trip last year. She stressed the benefits to students and that safety was addressed thoroughly.

The board recognized the value of the trip and requested fingerprint clearance of overnight chaperones.
